Newspaper Article (Print)

Example: Roberts, P. (2020, December 5). New study reveals alarming trends in global warming. The New York Times, p. A1.

Newspaper Article (online)

Author Last Name, First Initial. (Year, Month Day). Title of the article. Newspaper Name. URL

Example: Qamar, F., & Pandit, J. M. (2023, December 27). Need to be careful about tech-driven human resource management in HEIs. *Financialexpress*.

Make sure to italicize the newspaper name and capitalize only the first word of the title, the first word after a colon or em dash, and proper nouns.

Conference Paper

Author Last Name, First Initial. (Year). Title of the paper. Title of the conference proceedings (pp. page range). Publisher.

Example: Goyal, G. R., & Mehta, H. D. (2015). Multi-objective optimal active power dispatch using swarm optimization techniques. 2015 5th Nirma University International Conference on Engineering (NUICONE), 1–6.

Make sure to italicize the title of the conference proceedings and capitalize only the first word of the title, the first word after a colon or em dash, and proper nouns.
